

The officers are deemed to have been relieved on the date of expiry of the deputation period unless the competent authority has with requisite approval, extended the period of deputation in writing, prior to its date of expiry. In the event of the officers' overstaying for any reason whatsoever, they will be liable for disciplinary action and other adverse civil/service consequences which would include the period of overstay not being counted for service for the purpose of pension and that any increment due during the period overstayed being deferred with cumulative effect, till the date on which they re-join in their parent cadre.
