In the Order No. 362/2018-CUS /ASRA/MUMBAI dated 30.05.2018 in para 9 of page 4.

“ 9. In view of the above, Government allows redemption of the confiscated goods for re-export in lieu of fine. The impugned gold chain weighing 193.560 grams valued at Rs. 5,50,484/- (Rupees Five lakhs Fifty thousand and Four hundred and Eighty four) is ordered to be redeemed for re-export on payment of redemption fine of Rs. 2,00,000/- (Rupees Two lakhs) under section 125 of the Customs Act, 1962. ”

“9. In view of the above, Government allows redemption of the confiscated goods for re-export in lieu of fine. The impugned gold chain weighing 194.460 grams valued at Rs. 5,53,044/- (Rupees Five lakhs Fifty three thousand and Forty four) is ordered to be redeemed for re-export on payment of redemption fine of Rs. 2,00,000/- (Rupees Two lakhs) under section 125 of the Customs Act, 1962. ”
