In the Order No. 47/2018-CUS /ASRA/MUMBAI dated 15.02.2018 in para 8 of page 4

“ Government keeping in view the overall circumstances of the case, also reduces the penalty imposed by the Appellate Authority from Rs. 10,000/- ( Rupees Ten thousand) to Rs...6,500/- ( Rupees 6,500/- Six thousand five hundred ) under section 112(a) of the Customs Act,1962. The appropriate Customs duty leviable on the redeemed goods shall be required to be paid in accordance with the Customs Act,1962 and rules framed thereunder. ”

**May be read as**

“Government keeping in view the overall circumstances of the case, also reduces the penalty imposed by the Appellate Authority from Rs. 33,000/- ( Rupees Thirty three thousand) to Rs.16,000/- ( Rupees Sixteen thousand ) under section 112(a) of the Customs Act,1962. The appropriate Customs duty leviable on the redeemed goods shall be required to be paid in accordance with the Customs Act,1962 and rules framed thereunder.”
