This revision application has been filed by Shri H. Mohamed Abdul Kader (herein referred to as Applicant) against the Order in Appeal C. Cus No. /201 dated .0 .201 passed by the Commissioner of Customs (Appeals), Chennai.

- 3. Briefly stated the facts of the case are that the applicant, arrived at the Chennai Airport on 02.02.2012. He was intercepted and examination of his baggage resulted in the recovery of gold weighing 351 gms valued at Rs. 10,82,835/- (Rupees Ten Lakhs Eighty two thousand Eight hundred and thirty five). The gold was ingeniously concealed in the hollow metal channels holding the two wheels at the bottom of the stroller suitcase carried by the applicant.
- 4. The Applicant requested for provisional release which was rejected by the Original adjudicating authority, vide his order 391/23.12.2015.
- 5. Aggrieved by this order the Applicant filed an appeal with the Commissioner of Customs (Appeals) Chennai, The Commissioner (Appeals) vide his order No. 142/2016 dated 29.02.2016 rejected the appeal of the applicant. Aggrieved with the above order the Applicant has filed this revision application. A personal hearing in the case was scheduled to be held on 23.07.2018, the Advocate for the respondent Shri G. Derrick Sam attended the hearing, he pleaded for withdrawal of the Revision
