Respondent: Commissioner of CGST, Ludhiana.



**ORDER**

Revision Application No. 195/182/2018-R.A. dated 28.08.2018 has been filed by M/s Gilco Exports Ltd., Ropar (hereinafter referred to as applicant) against Order-in-Appeal No. LUD-EXCUS-001-APP-1209-18 dated 31.05.2018 passed by Commissioner (Appeals), Central Goods and Services Tax, Ludhiana, wherein the demand of Rs. 2,06,905/- confirmed vide Order-in-Original No. 02/DC/CE/RPR/14-15 dated 30.01.2015 has been set aside but a penalty of Rs. 50,000/- has been imposed.

2. Sh. G. S. Bhangoo, Advocate, representing the applicant, vide email dated 17.03.2021, has intimated that subsequent to filing of the subject revision application, they had filed application for settlement of their case under "Sabka Vishwas (Legacy Dispute Resolution) Scheme, 2019" and their case stands settled vide SVLDRS-4 certificate issued on 24.12.2019 by the designated committee. Sh. Bhangoo has, accordingly, prayed for withdrawal of the instant revision application.

3. In view of the above, the instant revision application stands disposed of as withdrawn.


