CORRIGENDUM

In Order No.646/2023-CUS(WZ)/2020-RA dated 12-09-2023, in page number 6, the following Para :

“10. In view of the above, the penalty of Rs. 4,00,000/- imposed under section 112(b) of the Customs Act, 1962, is reduced to Rs. 2,50,000/- (Rupees Two Lakh Fifty Thousand Only). The penalty of Rs.1,00,000/- imposed under section 114AA of the Customs Act,1962 is set aside.”
