ORDER NO. 07-17-04 DATED 14-9-2017 OF THE GOVERNMENT OF INDIA, PASSED BY SHRI R.P.SHARMA ADDITIONAL SECRETARY TO THE GOVERNMENT OF INDIA, UNDER SECTION 35 EE OF THE CENTRAL EXCISE ACT, 1944.



ORDER

A Revision Application No. 375/28/B/14-RA is filed by Zainab Bibi, a Pakistani national (here in after refer to as the applicant) against the order of the Commissioner (Appeal), Chandigarh.

2. In his order the Commissioner(Appeal) has already extended the period for Re-export of seized goods as per request of the applicant and upheld the order of Addl. Commissioner, Amritsar, with regard to penalty and R.F. The applicant has already re-exported the seized goods and she has now approached the GOI mainly for reduction in redemption fine and Personal Penalty.
3. The Government has considered the request of the applicant in the light of Order-in-Original and Order-in-Appeal passed by the department authority and it is found that the applicant has undoubtedly imported the gold in India illegally and the same has been allowed to be re-exported to Pakistan. Now, the issue is only whether the Refund and P.P imposed by adjudicating authority and upheld by the first appellat authority is excessive. After considering all the relevant facts, and circumstances of this case, the Government finds that the R.F and P.P imposed by the Original authority are just and proper and no interference is warranted in this matter.
4. Accordingly the Revision Application filed by the applicant is rejected.
