क्र. सं. 31/78/2000-वि.क.—सभी राज्यों/संघ शासित क्षेत्रों के मुख्य मंत्रियों तथा वित्त मंत्रियों के दिनांक 22-6-2000 को आयोजित सम्मेलन में लिए गए निर्णयों को मॉनीटर करने के लिए, मुख्य मंत्रियों की समिति ने राज्य वित्त मंत्रियों की एक अधिकार प्राप्त समिति के गठन की सिफारिश करते हुए, एक संकल्प पारित किया था।

2. इस संकल्प के अनुसार, इस प्रयोजनार्थ एक अधिकार प्राप्त समिति की नियुक्ति करने का निर्णय लिया गया है इस समिति में निम्नलिखित शामिल होंगे :—

3. डा. महेश सी. पुरोहित इस अधिकार प्राप्त समिति के सदस्य-सचिव होंगे।

4. समिति के विचारार्थ विषय इस प्रकार होंगे —

- राज्यों तथा संघ शासित क्षेत्रों द्वारा विक्री कर के एक समान न्यूनतम दर के क्रियान्वयन को मॉनीटर करना।
- विक्री कर आगति प्रोत्साहन योजनाएं तैयार कर की मॉनीटरिंग।
- राज्यों में मूलवर्धित कर को लागू करने के लिए समय-समयावधि पद्धति का निर्धारण।
- देश में विद्यमान केन्द्रीय विक्री कर पद्धति में सुधारों का मॉनीटर करना।

5. यह समिति अपर इस कार्य के लिए स्वयं अपनी पद्धति विकसित करेगी और केन्द्र तथा राज्य सरकारों/केन्द्र शासित क्षेत्रों से आवश्यक सूचनाएं प्राप्त कर सकती है।

6. राष्ट्रीय लोक विर एवं नीति संस्थान समिति को सचिवालयी सहायता उपलब्ध करवाएगी।

7. यह संकल्प इस विभाग के दिनांक 30-11-99 के संकल्प क्र. सं. 31/11/99-वि.क. तथा दिनांक 7-1-2000 एवं 8-6-2000 के समसंख्यक संकल्पों के अन्तर्गत किए गये संशोधनों के अधीन है।

2. In pursuance of this Resolution, the Government has decided to appoint a Empowered Committee for this purpose. It will consist of—

3. Dr. Mahesh C. Purohit will be Member-Secretary of the Empowered Committee.

4. The terms of reference of the Committee will be—

- (i) To monitor the implementation of uniform floor rates of sales tax by States and Union Territories.
- (ii) To monitor the phasing out of the sales-tax based incentive schemes.
- (iii) To decide milestones and methods for States to switch over to VAT.
- (iv) To monitor reforms in the Central Sales Tax system existing in the country.

5. The Committee will evolve its own procedure for its work and may call for information as may be necessary from Central and State Governments/UTs.

6. The NIPF & P will provide secretarial assistance to the Committee.

7. This supersedes this Department's Resolution F.No. 31/11/99-ST dated 30-11-99 and amendments made thereto vide Resolutions of even number dated 7-1-2000 and 8-6-2000.
