- Upon Joining as Member(Judicial) in the Customs, Excise and Service Tax Appellate Tribunal(CESTAT), their salary & allowance and other conditions of service will be governed by the Tribunal, Appellate Tribunal and other Authorities (Qualifications, Experience and other conditions of Service of Members) Rules, 2017, as amended from time-to-time. The appointment shall be subject to the final outcome of W.P.(C) 279/2017 pending before the Hon'ble Supreme Court of India.
- They are required to take charge of the Member(Judicial) in the Customs, Excise and Service Tax Appellate Tribunal(CESTAT) within 30 days from the date of issue of this order, falling which, their appointment will stand cancelled and they will be debarred for a period of three years from consideration for any appointment outside the cadre, without further notice.
