In the above referenced revision application dated 02/01/2014, I have already argued on 04/01/2016 at your office in New Delhi and ever since I have been waiting to know your decision.

In this regard, exactly after 9 months from the date of my arguments i.e. 04/01/2016, I especially travelled to New Delhi from Vadodara to know the actual status of my undecided revision application for which I had submit a letter at your office personally on 03/10/2016 but, very surprisingly, you did not respond my letter till date. Again I wrote to you on 03/11/2016 by post Register A D and again you did not respond my second letter it till date. Your non-cooperative behavior has shaken my faith from you though your being an Indian government administration. This is a flabbergasting experience.
