The O.S no 165/2014 – Batch A dated on 27/09/2014 was passed on me by the Assistant Commissioner of customs, Madurai airport, then the Appeal No. 184/2014(Cus) was filed by myself to the Commissioner of Customs and Central excise (Appeal I) Madurai, for that the reply (20.11.2014) for my appeal (184/2014) was rejected and O.S no 165/2014 – Batch A

was upheld. After that I have appealed against the Assistant Commissioner of Cutoms, Madurai airport and the Commissioner of Customs and central excise (Appeal) Madurai to Additional/Joint secretary (Revision Application), ministry of finance (department of revenue), New Delhi on 29/01/2015, to that the reply (copy attached) with file reference number F.NO.373 / 69 / B / 15 - R.A was sent to me and directed myself to pay the revision application fee through TR 6 challan which was received on 08/05/2015 and it was paid by myself on 13/05/2015 with the challan no (000915) and sent on 14/05/2015 to Additional /Joint secretary (Revision Application), ministry of finance (department of revenue), New Delhi. 
