ii) The Revision Applications are dealt with on merits of the case and are taken up zone wise and subject wise based on chronological sequence from the date of filing. Revision Orders are passed after following principles of natural justice. All cases would be taken up according to seniority for disposal.

iii) Yes, currently revision applications of 2014 are being granted personal hearing.

iv) Yes, if the issue involved is same.

v) There is no prescribed time limit within which the competent authority is bound to hear the matter and pass orders.

vii) The reason for delay of almost 4 years in revision application No. 380/04-06/DBK/14 - R.A. and almost 22 months in revision applicatin No. 375/41-A/DBK/16-R.A. is due to a court stay on the issue of competence of Joint Secretary(R.A.) to revise orders of Commissioner (Appeals), (same rank), as the work in this unit had came to a stand-still. But with the appointment of Additional Secretary on 20/07/2017 by the government, the work is resumed and the Revision Applications are being taken up for disposal on seniority basis.
