2. The posts of Assistant, UDC, LDC, PSO, Sr. PPS, PPS, Private Secretary, Personal Assistant and Stenographer Grade 'D' are filled up by the Department of Personnel & Training (DOP&T). The vacancies are conveyed periodically to the DOP&T through the Cadre Administration Section of Department of Expenditure. The direct recruitment quota of the posts of Assistants,


LDC, Stenographer Grade 'D' and Stenographer Grade 'C' are filled up through the Staff Selection Commission. The posts of Hindi Translator are filled up by the Department of Official Language. The details regarding eligibility, mode of selection, etc. of these posts are available on the website of DOP&T (http://persmin.nic.in/DOPT_CSDivision) and Department of Official Languages (www.rajbhasha.nic.in) respectively.

3. Vacancies in the grade of Staff Car Driver (Spl. Grade) and Staff Car Driver (Grade-I) are to be filled up on promotion basis from the respective lower grade. In so far as MTS are concerned, these are filled up directly through Staff Selection Commission, to which requisition has been sent. Matriculation or equivalent is the educational qualification for the post of MTS. The vacancies will be filled up on receipt of nominations from SSC.


