(c) Reason for PH not being held currently in the case of CWP No. 24967 of 2015 and CWP No. 26321 of 2015, the Hon'ble High Court of Punjab & Haryana held that Revisionary Order passed by the Revisionary Authority of the same rank as that of Commissioner (Appeal) is not permissible as per law. Against the said order of Hon'ble High Court department had filed SLP No. SLP (Civil) CC 19063 of 2016 before the Hon'ble Supreme Court of India which was dismissed by the Apex Court. The Joint Secretary (Revenue) is not in a position to pass Revision Orders. The department is in the process of settling the legal and administrative issues that have so emerged with regard to appointment of the appropriate officer to decide Revision Application on behalf of Government of India.

(d) The details for the year 2015 and 2016 regarding serial number, case numbers, date of receipt, date of admission of such cases in the registry, date of personal hearing, date of disposal.
