1. I am Kailash Chandra Ghumaria (82066 IRS 1982 batch), Pr.CCIT (B&J) stationed at Patna.
2. One and half years back I got promotion as Pr.Chief Commissioner of Income tax and was posted to Patna from Raipur. In the same panel my batch mates Smt. Neena Kumar (82021), Shri Akhilesh Ranjan (82037) and Shri P. K.Dash (82042) were promoted as Pr.CCIT.
3. Department of Revenue vide its Office Memorandum under F.No. A-12026/20/2017-Ad.I dated 04.07.2018 had sought applications for selection for the post of Members of the CBDT under the Department of Revenue against the anticipated vacancies, being 4(Four) in number, likely to fall vacant in the Financial Year 2018-19. It is pertinent to mention here that selection to the post of Member in CBDT is governed as per **Recruitment Rules (RR) of Chairman and Members, 2017 notified in the Gazette of India on 17.07.2017** as well as guidelines approved by the Hon'ble Prime Minister which has been Notified vide No. 3-3/2006-CS(A) dated 13.07.2006. I have submitted my application for selection to the post of Member of Central Board of Direct Taxes (CBDT), New Delhi vide this office letter F.No. Pr. CCIT/Pat/Pers/2018-19/C-113 dated 9<sup>th</sup> July, 2018.
4. Consequent upon approval of panel by the Appointments Committee of Cabinet, Appointment Orders in respect of 03 (Three) Officers belonging to 1982 Batch of IRS have been issued vide Orders Nos. 242-244/2018 dated 06.11.2018 appointing them as Members in CBDT, New Delhi. As per my seniority my name in the panel is required to find place at Sl.No. 04 in the panel and accordingly consequent upon superannuation of Sri Arbind Modi, then Member in CBDT, New Delhi on 30.09.2018, one vacancy has arisen against which the next name appearing in the panel at Sl. No. 04 is required to be released for appointment to the post of Member in CBDT. The fourth name from the panel is yet to be released and my name is required to be considered against the said vacancy arisen due to superannuation of Sri Arbind Modi on 30.09.2018.

5. Please provide me the copies of the minutes/drafts/ordersheets sent by Cabinet Secretariate for the selection of the Members in the CBDT in which Mrs. Neena Kumar, Shri Akhilesh Ranjan and Shri P. K. Dash were selected as Members in the Central Board of Direct Taxes and I (Kailash Chandra Ghumaria) was denied selection as Member of the Central Board of Direct Taxes.
6. Please provide me the copies of the ordersheets of the ACC/PMO for the selection of Members in the Central Board of Direct Taxes in which Mrs. Neena Kumar and others were selected.
7. Please provide me the inputs of the IB(Intelligence Bureau) and CVC (Central Vigilance Commission) on Mrs. Neena Kumar, Shri Akhilesh Ranjan and Shri P. K.Dash, me (Kailash Chandra Ghumaria), Shri Ashu Jain and Shri Prabhash Shanker.
8. One and half years back I got promotion as Pr.Chief Commissioner of Income tax and was posted to Patna from Raipur. In the same panel Smt. Neena Kumar, Shri Akhilesh Ranjan and Shri P. K.Dash were promoted as Pr.CCIT. It is very interesting that all these three officers of 1982 batch i.e. my batch have been promoted as members in CBDT while me (Kailash Chandra Ghumaria) has been denied the promotion/selection as member of the CBDT. One post is lying vacant as member of the CBDT. Please state the reasons how these three officers of 1982 batch have been selected as members of the CBDT and how hard working officer like me and an officer of impeccable integrity has been denied as promotion/selection as member of the CBDT.
9. Please state me why three members were only selected for the post of Members in the CBDT against the 3 posts Mrs. Smt. Neena Kumar, Shri Akhilesh Ranjan and Shri P. K.Dash and why one post of the member, CBDT has been kept vacant, denying me, my right as promotion/selection as Member of the CBDT.
10. Please provide me the minutes of 360 degree profile done by the PMO for the selection of the Members of the CBDT in which Mrs. Neena Kumar and others were selected and I was denied my right for selection as member of the CBDT.
11. Please provide me the names of the persons/officers/organizations from whom the inputs have been taken for the 360 degree profiling of Mrs. Neena Kumar, Shri Akhilesh Ranjan, Shri P K Dash, me (Kailash Chandra Ghumaria), Shri Ashu Jain and Shri Prabhash Shanker.

12. Please provide me the comments/note of Cabinet Secretary Shri P K Sinha, the comments/note of Shri Bhashker Khulbe, Secretary of PMO, notes/comments of Sh. P K Mishra, Addl. Secretary to the PMO, the comments/note of Shri Rajiv Topno, PS to the Hon'ble Prime Minister, the notes/comments of Sh. Narendra Modi, Hon'be Prime Minister of India for the selection of the members of the CBDT in which Mrs. Neena Kumar, Shri Akhilesh Ranjan and Shri P K Dash were selected as Members of the CBDT, New Delhi while I (Kailash Chadra Ghumaria) was denied the selection/promotion as member of the Central Board of Direct Taxes.

13. Please provide me the minutes/order sheets of the ACC/PMO finally drawn for the selection of the Members of the CBDT which was finally supplied to the Department of Revenue for the selection of the members of the CBDT and denial of me (Kailash Chandra Ghumaria) for selection of the Member of the Central Board of Direct Taxes.
