Sir,

I am to refer to your RTI application dated NIL, received through RTI Cell, Department on 02.07.2019. So far as Ad.I Section is concerned of which the undersigned is CPIO, the point wise information is as under:

Point No.1 & 2: There is no file where in communication received from Cabinet Secretariat regarding tenure of officers in sensitive and non sensitive post in terms of CVC's instructions was dealt. However, a communication of Cabinet Secretariat relating to Review of mechanism to Ensure Probity among Government Servants was received in the Ad.I Section from Vigilance Cell, Department of Revenue. As the Cabinet Secretariat had not sought any compliance report, no reply to Cabinet Secretariat was sent.

Point No.3: As there is no larger public interest served by the disclosure of the information, the information is denied under Section 8 (1) (e) of Right to Information Act.

Point No.4: Only Sections are identified as sensitive/non sensitive and the posts of Section Officer/Under Secretary/Deputy Secretary and Director are not categorized as sensitive/non sensitive. The list of Section Officer/Under Secretary/Deputy Secretary and Director of CSS being in-charges of these Sections with more than three years tenure is attached.

Point No.5: Section Officer/Under Secretary looking after the sensitive section with more than 3 years are normally transferred. However, the posting/transfer of officers is one of the administrative functions which are being done in a routine manner and the officers have been retained/not retained on the basis of the prevailing work exigencies in the concerned Divisions/Sections.

2. In case you are not satisfied with the reply, you may submit your appeal before the Appellate Authority within 30 days. The name and address of the Appellate Authority is as under:
