

Sub:-Application under RTI Act, 2005.

Shri Amit Chadha may refer to his application (hard copy) dated NIL and online application dated 23.12.2013 seeking information under the Right to Information (RTI) Act, 2005, received in Ministry of Finance (Department of Revenue) on 23.12.2013.

2. Information sought *vide* said application dated 23.12.2013, para A *ibid*, is as under:-
- Ketamine was declared as a 'Psychotropic Substance', under the Narcotic Drugs and Psychotropic Substances (NDPS) Act, 1985, vide Notification S.O. 311 (E) dated 10.02.2011 published in the Gazette of India, Extraordinary, Part II, Section-3, Sub-section (ii). The said Notification S.O. 311 (E) dated 10.02.2011 was laid on the Table of Lok Sabha and Rajya Sabha on 12.08.2011 and 16.08.2011 respectively, as required under the NDPS Act, 1985, Section 77 *ibid*. While forwarding the said notification for laying on the Table of Lok Sabha and Rajya Sabha, the Lok Sabha Secretariat and Rajya Sabha Secretariat were informed to lay the notification for a period of 30 days which may be in one or more successive sessions.
 - Copy of this communication is being endorsed to Lok Sabha Secretariat and Rajya Sabha Secretariat for providing information on the dates / period / exact duration for which the notification was laid before respective House.

3. Aforesaid application of Shri Amit Chadha, to the extent it relates to Department of Revenue, is treated as disposed of at this level. However, if Shri Amit Chadha is not satisfied with the above information, he may prefer an appeal, within a period of 30 days, to the Appellate Authority, viz. Director (NC), Department of Revenue, Ministry of Finance, North Block, New Delhi-110001.
