

Subject : Appeal under Section 19(1) of Right to Information Act-2005 by Shri Rohit M. Mengde – regarding.

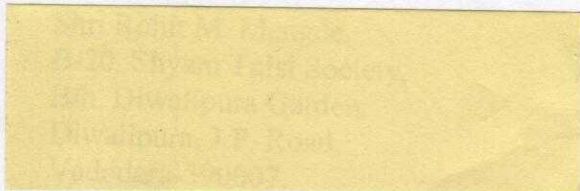
Whereas Shri Rohit M. Mengde vide his letter dated 14.06.2019 (received by this Department on 21.06.2019) has filed an Appeal under section 19(1) of the RTI Act-2005 with the First Appellate Authority & Deputy Secretary (Admn), Department of Revenue.

2. And whereas an Appeal has been raised on the contention that the applicant not satisfying with the reply of his RTI application.
3. The APPEAL of Shri Rohit M. Mengde was considered in detail and it has been observed that the CPIO/Under Secretary (Ad.I B) vide letter dated 15.05.2019 has already replied that the information sought by the Appellant does not pertain to them, hence, 'Nil' reply was sent to the applicant.
4. Perhaps, some information in the aforesaid application are pertain to CPIO (RTI Cell), Department of Revenue, Hence, I order the CPIO (RTI Cell, Department of Revenue) to provide the aforesaid information as sought by the Appellant. Accordingly, the Appeal is disposed off.
5. The Appellant may prefer an appeal u/s 19 (3) of RTI Act, 2005 before the Central Information Commission, CIC Bhawan, Baba Gang Nath Marg, Munirka, New Delhi, Delhi 110067 against this order with 90 days, if he so desire.



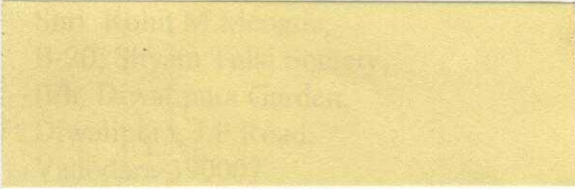

I am directed to refer to First Appellate Authority's Order No. R-20011/24/2019-Ad.1(B) dated 04.07.2019 on the subject cited above and to furnish herewith the point wise information sought vide RTI Application dated 29.04.2019 as follows :

Point 0. Your RTI Application has already been transferred/forwarded to CPIO & Under Secretary (CX-9), Central Board of Direct Taxes vide endorsement No.1127685/2019-RTI Cell dated 03.05.2019 for providing the requisite information directly to you (copy enclosed). Shri V.Ganesh Kumar, Under Secretary (CX-9) is CPIO for Central Board of Indirect Taxes & Customs-Indirect Taxes and Shri S.C.Gangotri, Under Secretary (Cus-III) is the CPIO for Central Board of Indirect Taxes & Customs-Customs .

Point 1. The copy of diary register of inward dak maintained by the R&I (R) Section, Department of Revenue is enclosed for reference.

Point 2. RTI fees is received in the form of cash, IPO or demand draft is drawn in favour of DDO (Cash) or PAO, Department of Revenue. However the cash, IPOs or Demand Draft received as RTI fees by both the CPIOs, CBIC is also retained by the RTI Cell, Department of Revenue. After compiling the list of IPOs, demand draft & cash received, the list along with the IPOs, DD & cash are forwarded to the DDO (Cash)/PAO Department of Revenue for encashment.

The same was diarized in the RTI Cell, Department of Revenue on 06.02.2019 after retaining the IPO it was forwarded/transferred to the then CPIO & Under Secretary (Ad.1B), Department of Revenue vide computer diary no. 1054496/2019-RTI Cell (copy enclosed).
