

Settlement Commission (Income-tax or Wealth-tax) (Administrative Officer) Recruitment Rules, 2004.

NOTIFICATION

G.S.R. 293.- In exercise of the powers conferred by the proviso to article 309 of the Constitution, and in supersession of the Settlement Commission (Income-tax or Wealth-tax) (Administrative Officer) Recruitment Rules, 1982, except as respects matters which may be done before such supersession, the President hereby makes the following rules namely:

1. Short title and commencement.- (1) These rules may be called the Settlement Commission (Income-tax or Wealth-tax) (Administrative Officer) Recruitment Rules, 2004.

(2) They shall come into force on the date of their publication in the Official Gazette.

1. Number of post, classification and scale of pay.- The number of post, its classification and the scale of pay shall be as specified in columns 2 to 4 of the Schedule annexed hereto.

3. Method of recruitment, age-limit qualifications etc.- The method of recruitment to the said post, and other matters relating thereto shall be as specified in columns 5 to 14 of the said Schedule.

4. Disqualifications.- No person, -

(a) who has entered into or contracted a marriage with a person having a spouse living; or

(b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to any of the said posts:

Provided that the Central Government may, if satisfied that such marriage is permissible under the provisions of the law in force in the person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

5. Power to relax:- Where the Central Government is of the opinion that it is necessary or expedient so to do for special reasons to be recovered in writing, and in consultation with the Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.

6. Saving.- Nothing in these rules shall affect reservations, relaxation of age-limit and other concessions required for Scheduled Tribes, the other Backward Classes, Ex-Servicemen and other special categories of persons, in accordance with the rules issued by the Central Government from time to time in this regard.
